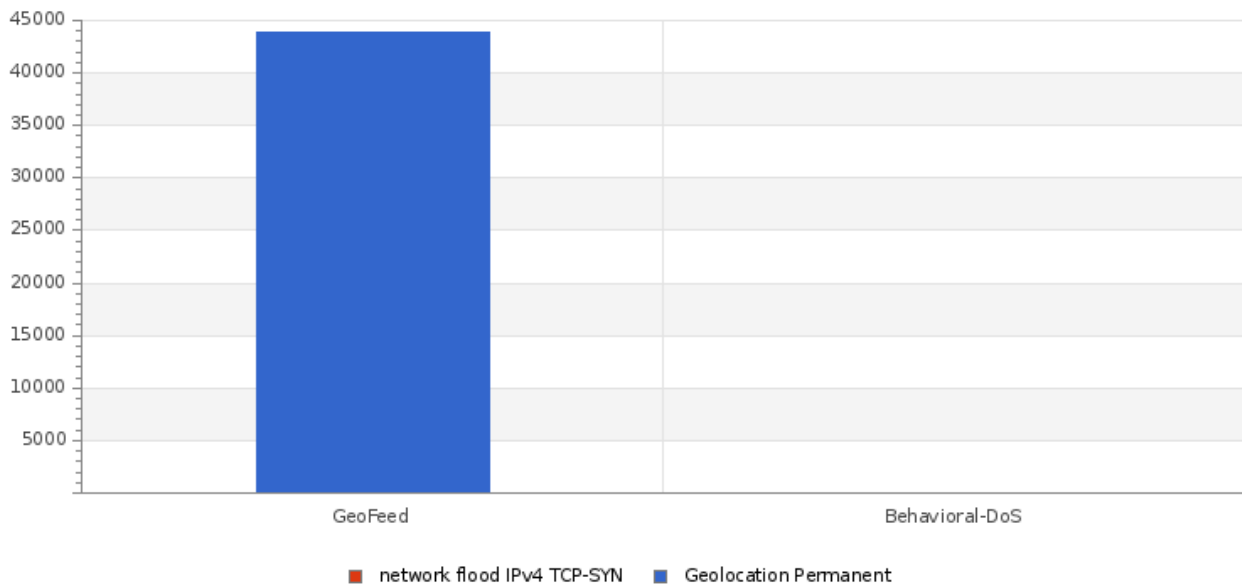

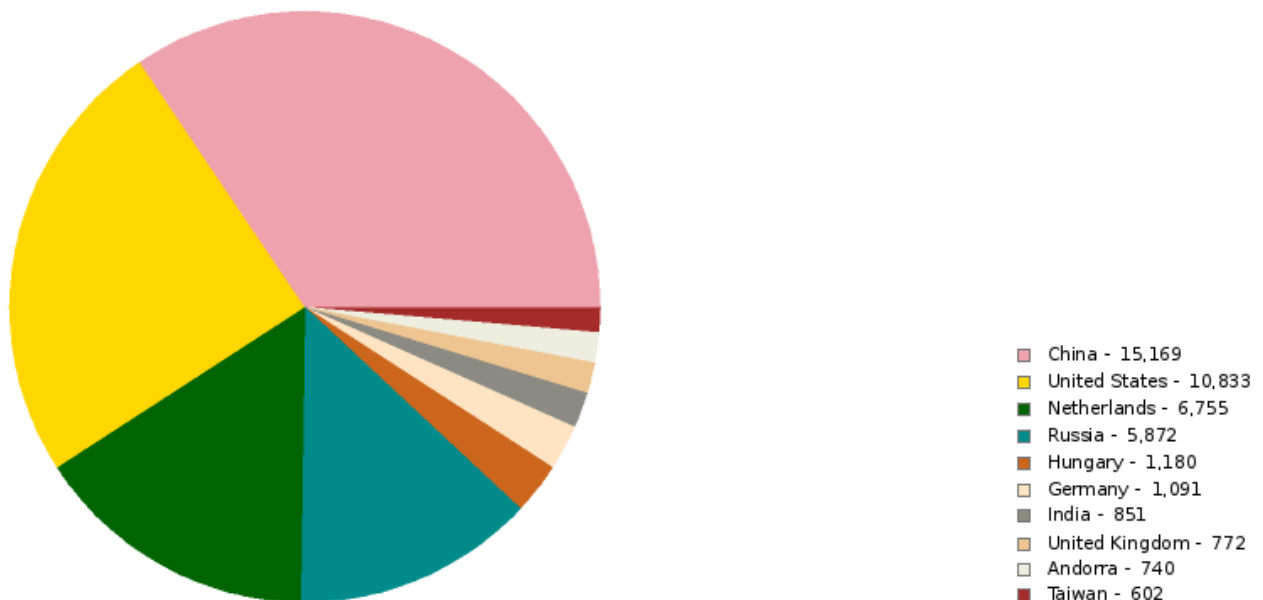

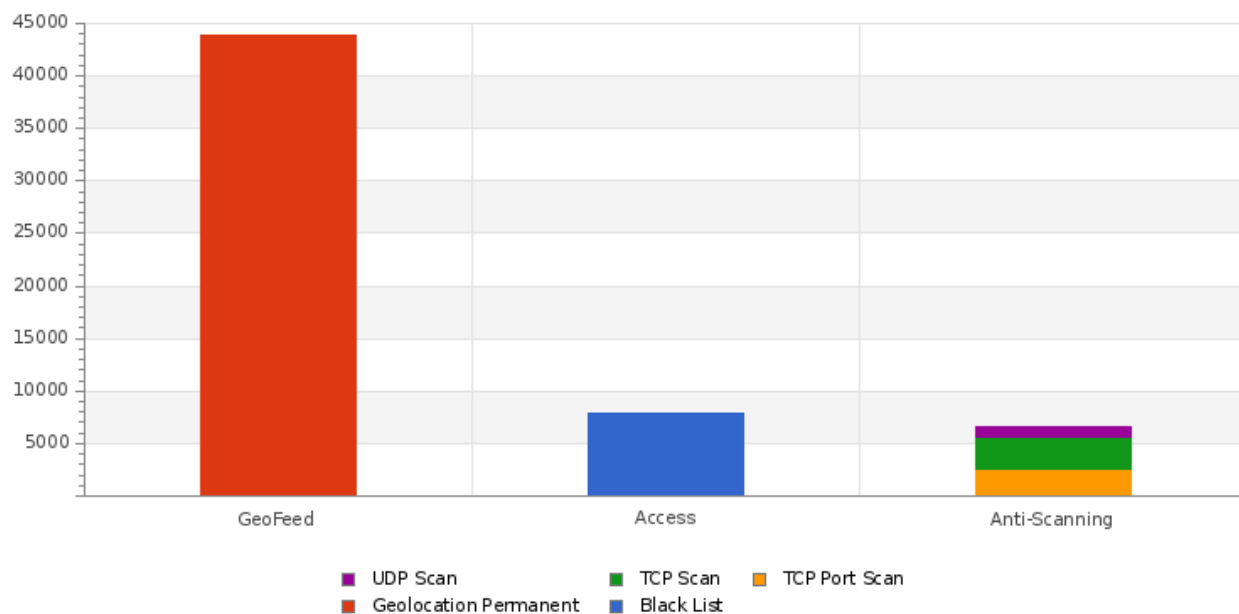
Executive Summary - Top Attacking Countries



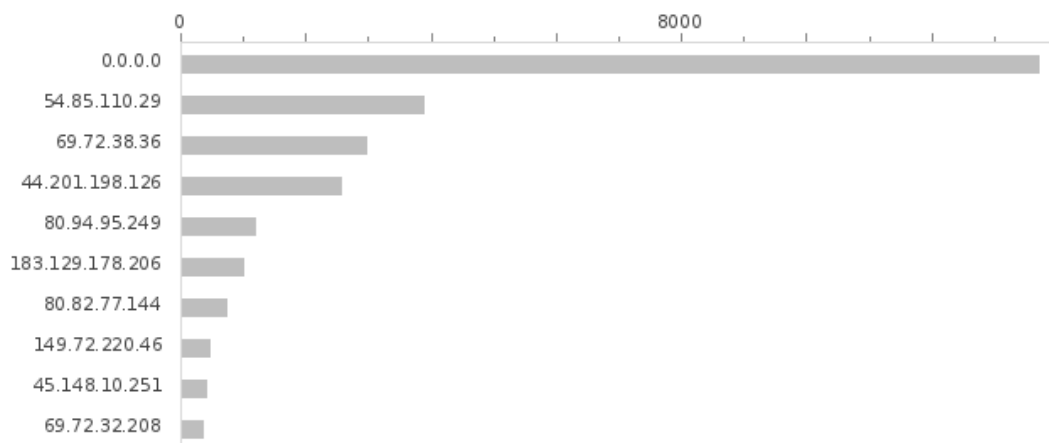

Types of Blocked Attacks



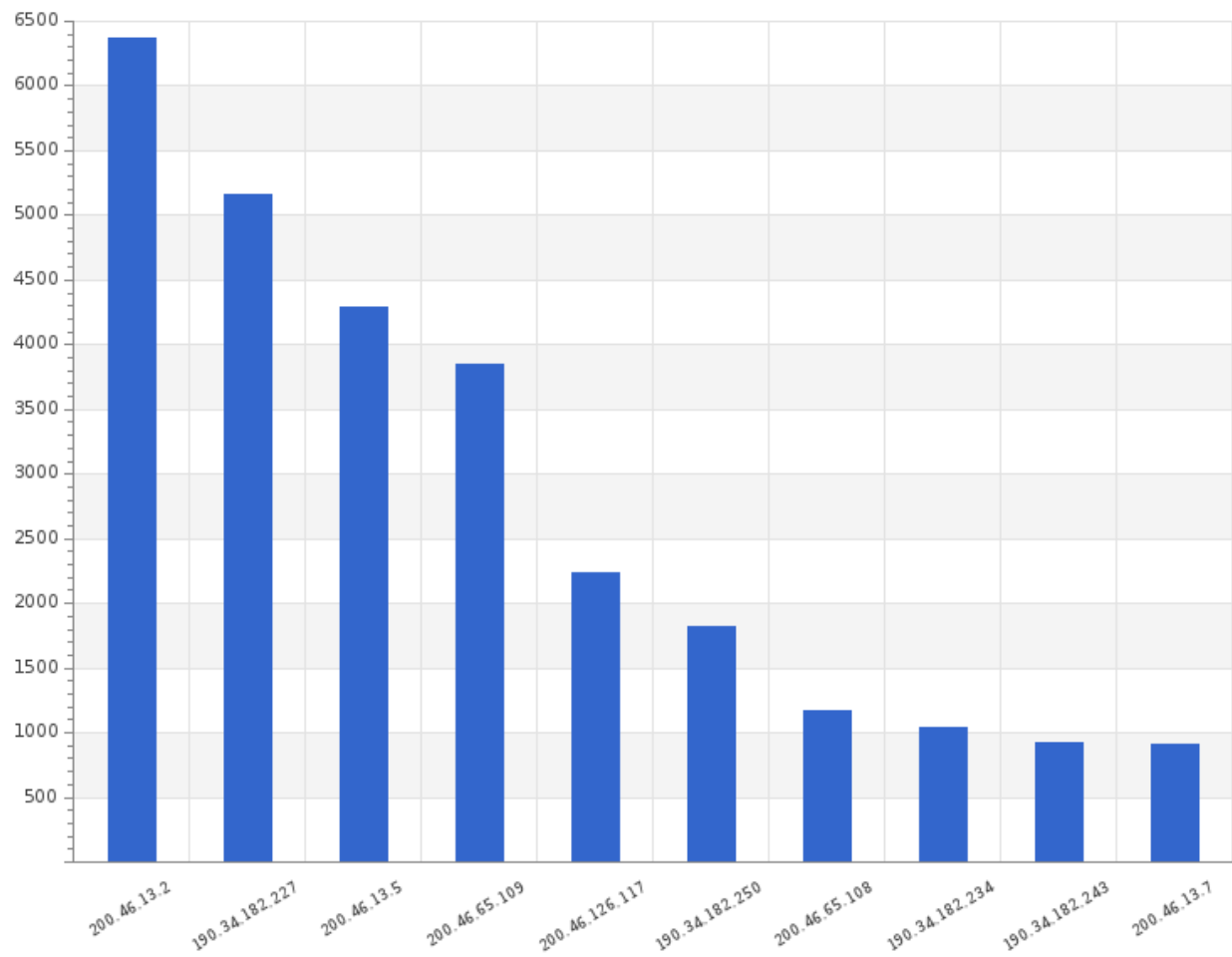
Top Attack Sources

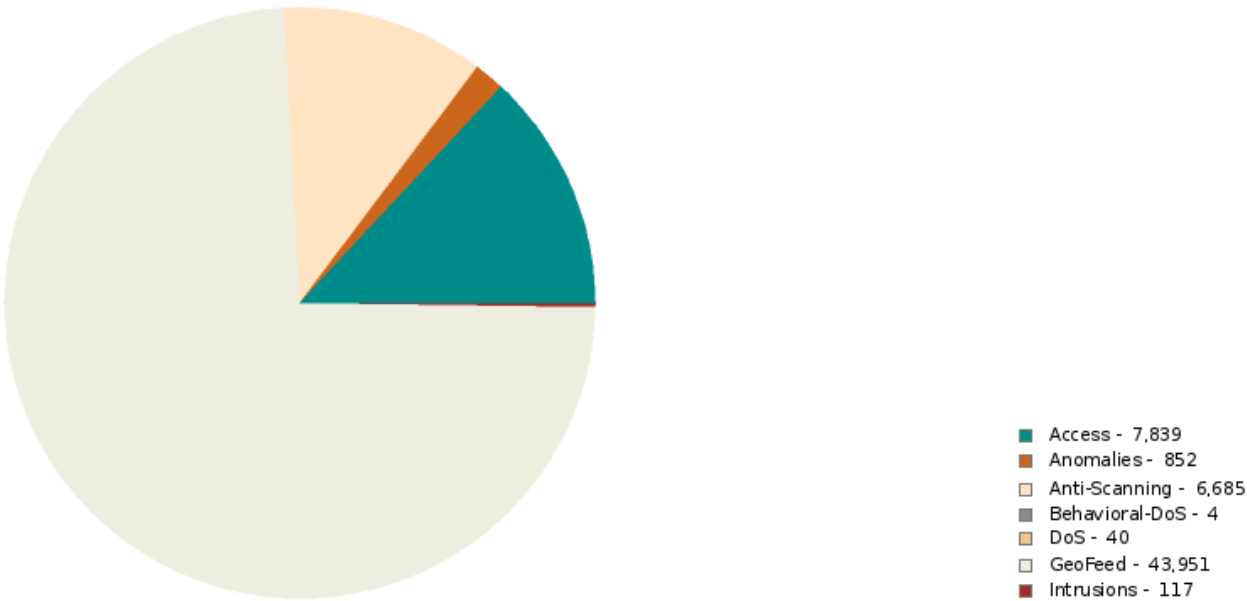
Top Assets Protected

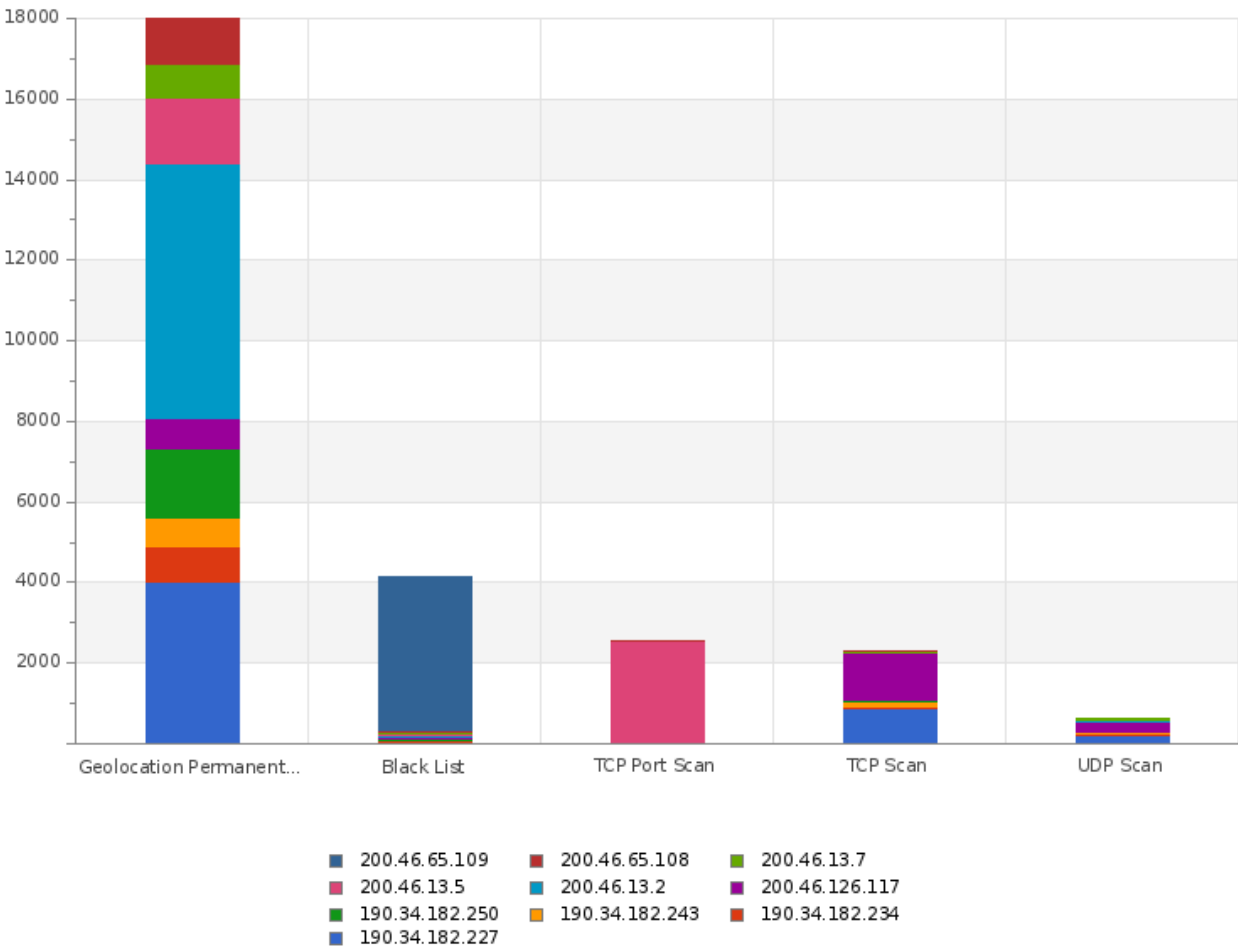


Top Attack Type Per Protected Asset

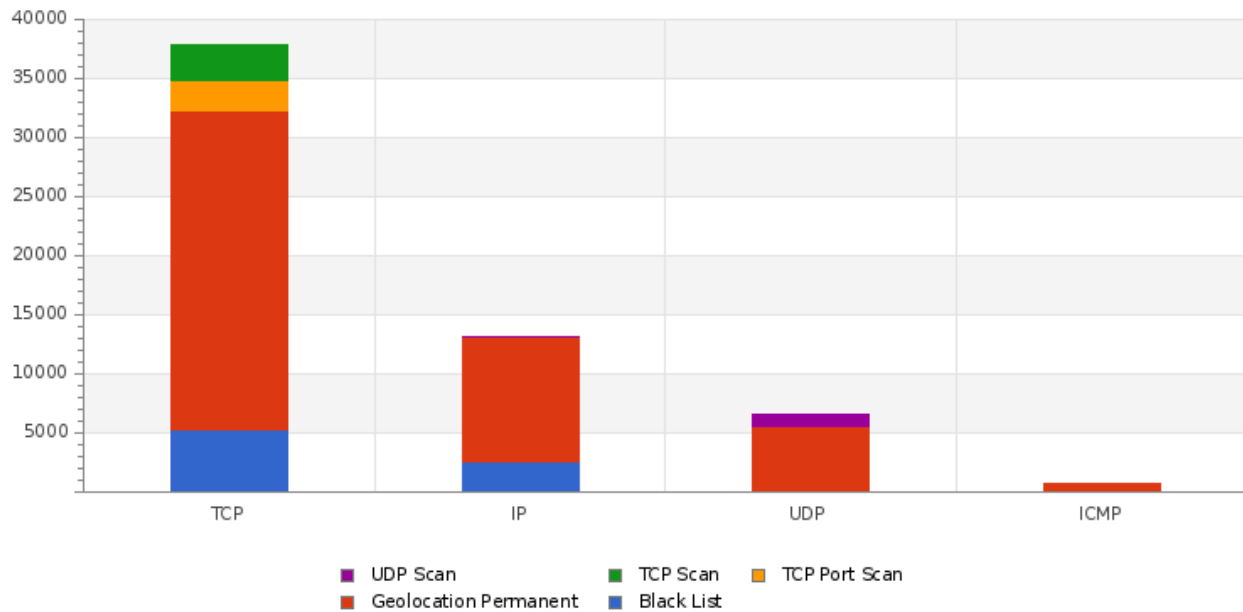

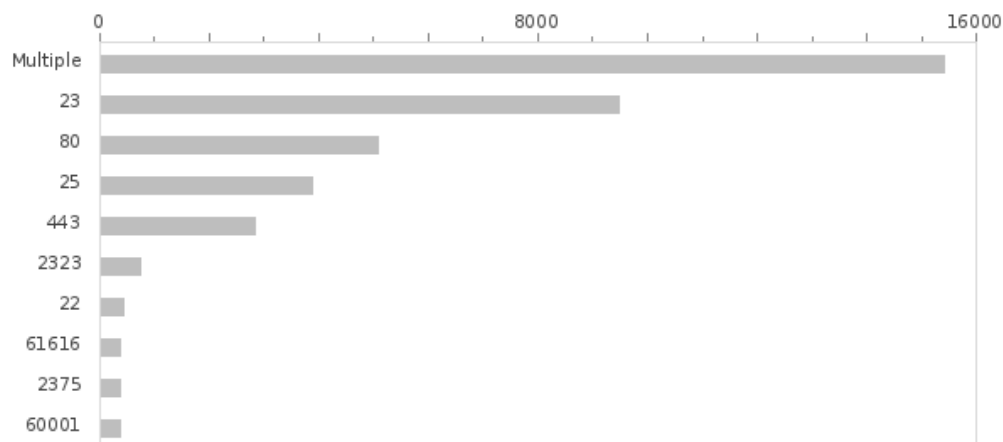

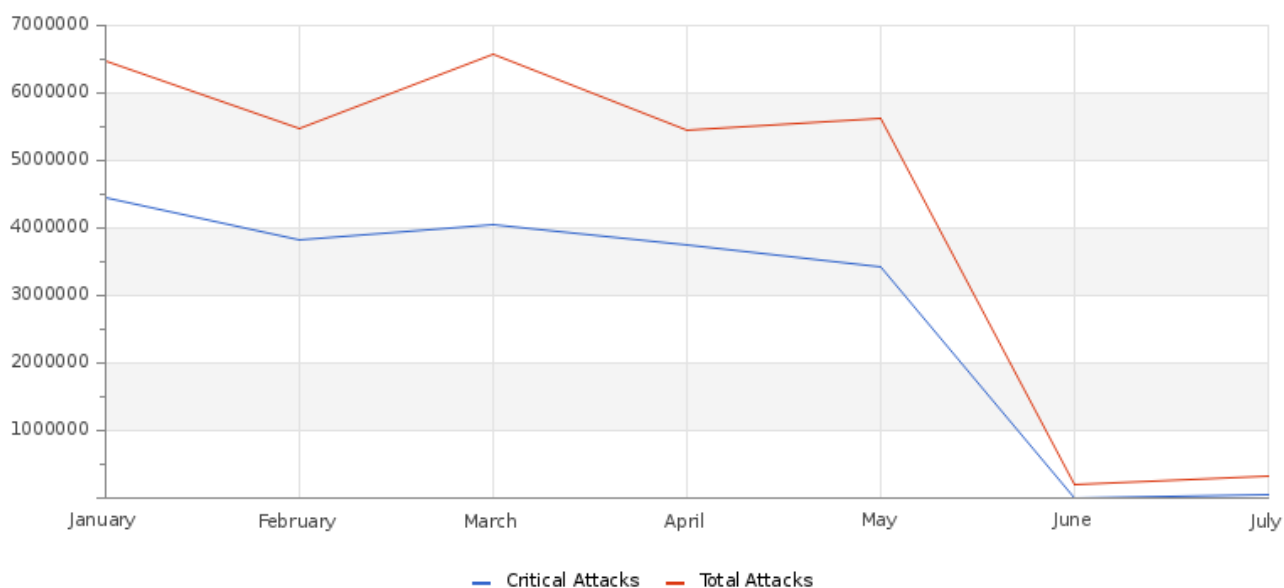

Executive Summary - Attacks Blocked by Destination Port



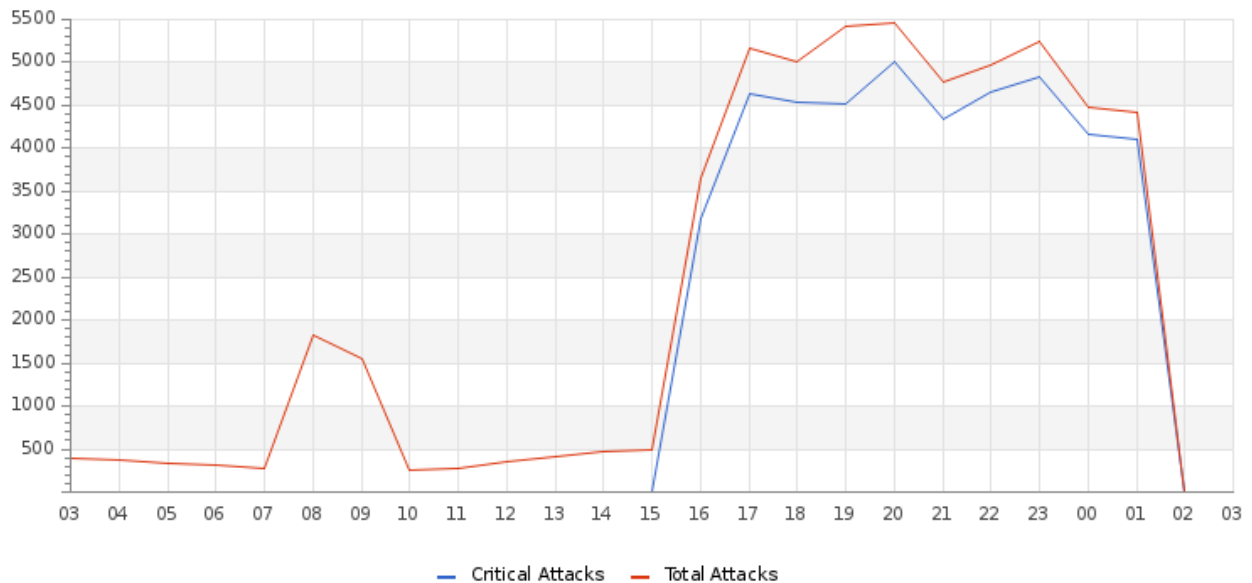
Total & Critical Attacks Per Month In Last 6 Months
